FURTHER ORDERED that the suspension of said Order of Commitment shall terminate and the said Order shall again become effective on the 12th day of September, 2006, at 8:01 pm, unless otherwise directed by further Order of this court.

DECISION & ORDER

The motion of the Receiver to re-calendar the hearing date is granted upon oral argument and after a review of the papers. On March 23, 2006 this court issued an order which indicated, in part, that the Receiver had to provide the Attorney General with a copy of the decision, as well as to notice the sureties and all persons interested in the property of the corporation. In addition, the receiver had to publish a notice, once a week for six successive weeks in at least two newspapers of general circulation in New York, which would provide a court date for this matter. As the receiver inadvertently did not meet these deadlines, it is hereby

ORDERED that, in accordance with B.C.L. § 1213, the Receiver shall provide a certified copy of this decision and order to the attorney-general of the State of New York, within thirty days of the receipt thereof; and it is further

ORDERED that, in accordance with B.C.L. §§ 1215 and 1216, the Receiver shall give no less than eight days' notice to the sureties on the bond, and notice to all persons interested in the property of the corporation, of the filing of this final accounting and request for commissions and for permission to resign, and shall do so by publishing such notice once a week for six successive weeks in at least two newspapers of general circulation in New York, setting forth 11:30 a.m. on

September 11, 2006, at Room 438, 60 Centre Street, New York, New York 10007 as the date and location at which the Receiver and all interested parties are expected to appear, and the Receiver shall present this final accounting and the court shall hear any objections and concerns of such interested persons to show cause why the Receiver should not be permitted to resign; and it is further

ORDERED that the Receiver's motion for a final accounting, commissions and permission to resign is held in abeyance; and it is further

ORDERED that, as an Order of Commitment was entered on February 19, 1993, directing the Sheriff of the County of New York to Arrest Judith Herskowitz, ████████ Herskowitz and ████████ ████████, this court is lifting said Order and Warrant, only as to Judith Herskowitz, pursuant to a separate Order of today's date, if Herskowitz chooses to appear on September 11, 2006 at 11:30 a.m. at Room 438, 60 Centre Street, New York, New York 10007.

This shall constitute the decision and order of the court.
